\$501 to \$2,000	\$22.32 for the first \$500 plus 2.89 for each additional \$100 or fraction thereof, to and including \$2,000
\$2,001 to \$25,000	\$65.78 for the first \$2,000 plus \$13.30 for each additional \$1,000 or fraction thereof, to and including \$25,000
\$25,001 to \$50,000	\$371.68 for the first \$25,000 plus \$9.59 for each additional \$1,000 or fraction thereof, to and including \$50,000
\$50,001 to \$100,000	\$611.56 for the first \$50,000 plus \$6.65 for each additional \$1,000 or fraction thereof, to and including \$100,000
\$100,001 to \$500,000	\$944.06 for the first \$100,000 plus \$5.32 for each additional \$1,000 or fraction thereof, to and including \$500,000
\$500,001 to \$1,000,000	\$3,072.06 for the first \$500,000 plus \$4.51 for each additional \$1,000 or fraction thereof, to and including \$1,000,000
\$1,000,001 to \$5,000,000	\$5328.31 for the first \$1,000,000 plus \$2.99 for each additional \$1,000 or fraction thereof, to and including \$5,000,000
\$5,000,001 to \$15,000,000	\$17,081.87 for the first \$5,000,000 plus \$1.46 for each additional \$1,000 or fraction thereof, to and including \$15,000,000
\$15,000,001 and above	\$31,884.18 for the first \$15,000,000 plus \$0.96 for each additional \$1,000 or fraction thereof

Other Inspections and Fees:

- (1) Inspections outside of normal business hours (minimum charges - two hours) **\$47.00** per hour*
- (2) Reinspection fees when assessed by the building official under the provisions of Section 108.8 **\$47.00** per hour*
- (3) Inspections for which no fee is specifically indicated (minimum charge - one-half hour) **\$47.00** per hour*
- (4) Additional plan review required by changes, additions, or revisions to approved plans (minimum charge - one-half hour) **\$47.00** per hour.

***Or the total hourly cost to the jurisdiction, whichever is the greatest. This cost shall include supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved.**
